The Port Charlotte Fall Music Festival for 2012, will be held on November 17, 2012, from 10:00 a.m. – 10:00 p.m. and will be located at 19190 Cochran Blvd, Port Charlotte, on the property of the Edgewater United Methodist Church, Inc. The Port Charlotte Fall Music Festival for 2012, is an outreach event sponsored by the church and many local businesses. There will be a large carnival, lots of food, several bands with CDs on the market and many vendors. There have already been over 160 bands who are requesting to attend. The carnival is **FREE** for those who want to attend. There is no cost for parking, admission, the carnival or even the food.

This is a great opportunity for vendors to make a lot of money because vendor's wares are the only thing that anyone will be able to spend money on. We only have room for 50 vendors, so it's important that your application and check are received right away. This is an event that no vendor will want to miss. Terms & Conditions/Operating Guidelines

1. Any and all concerns or questions are to be directed to the team leader.
2. Submission of application does not guarantee acceptance. Vendors will be considered based upon the uniqueness of their product(s) and/or services and whether or not a sufficient number of vendors selling like product(s) or services have already been accepted.
3. No items may be sold by a vendor that are in relation to alcoholic beverages, pornographic material, knives, guns or any other item considered offensive to the church. If the team leader deems that an item is of this category vendor will be ask to remove such item from display and/or for sell immediatly. If vendor refuses to remove such item, vendor will be subject to removal from the property.
4. There is to be no consumption of alcohol while on the church property.
5. Booth rental cost for a 10'x10' space is \$95.00.
6. Make all rental checks payable to Edgewater United Methodist Church and mail completed application and checks to the team leader at PO Box 313, Fort Ogden, FL 34267.
7. There will be a \$40.00 charge for any check that is returned by the Vendor's bank for Insufficient Funds or Stop Payment.
8. Electricity is not available.
9. There will be no reimbursement of fees or credits given for reserving booth space after the date of acceptance by the team leader, regardless of whether or not vendor attends the event. This is a rain or shine event.
10. Vendor booth spaces will be inside the church and security will be provided on Friday evening November 16, 2012, until the opening of the Festival on November 17, 2012.
11. Vendor is responsible for paying all State of Florida sales tax on products sold.
12. Vendor is responsible for all Department of Health, State of FL, county registrations, licensing and business taxes required.
13. Vendors may arrive to set-up at noon on Friday, November 16, 2012, and set-up must be completed no later than 8:30 a.m. on November 17, 2012.
14. All vendors business and selling will stop during the Festival hours from 5:45 p.m. – 7:15 p.m. due to church services being held during this time. This will be an opportunity for vendors to restock their booth space, get a bite to eat and drink or join us for church services in the sanctuary.
15. Vendors must not break down their booth until the close of the Festival.
16. Additional product(s) or services not listed on the vendor's original application may not be offered for sale without prior approval of the team leader.
17. All vendors are responsible for cleaning up their booth space, removing their trash and any items not sold at the end of the Festival.
18. Vendors must provide their own tables and chairs. All tables are to have a table cloth covering on them.
19. No inappropriate or offensive language is to be used and no hawking or yelling is allowed.
20. Team leader reserves the right to add to or delete from the Terms & Conditions/Operating Guidelines. Vendors will be notified of any additions or deletions.
