To our Merchandise Vendors—Past and Future—Welcome!

Please mark your calendars for the 14th Annual Irish Festival of Cape Coral. The fest will take place on Saturday, March 3rd & Sunday, March 4th, 2018. On Saturday the festival hours are 12 Noon to 8pm. On Sunday, the festival starts at 12 Noon and continues until 8pm. The venue for the festival will be at the German American Social Club at 2101 SW Pine Island Road in Cape Coral Florida 33991 .Many vendors said they did well promoting or selling their product. We will be working diligently on placement of vendors which will allow all vendors a good location on the grounds. We intend to be the same family oriented fest we have always been. The German American Social Club is a great venue which many events have been held in the past. As many of our vendors know there is permanent fencing and a permanent admission gate. This promotes security for the vendors. There is a huge amount of free parking available which is organized and well maintained. The location of the fest is very easy to find. The park has electricity available for all vendors.

We ask that your booth space be eye-catching and if possible fit the theme of Irish culture. Vendors who are coming from a distance should make arrangements for overnight accommodations. No vendor will be allowed to stay overnight on festival grounds. No exceptions. The park will be locked at close of festival hours on Saturday evening. Vendors may set up after 12pm on Friday, March 2nd and after 8:30 am on Saturday, March 3rd. Early tear downs are prohibited.

Each vendor will be given a site space and number. Because we want to ensure that our vendors achieve maximum sales, we will be limiting the number of vendors offering the same items to the consumers. Those vendors not accepted will have their money refunded. No site will be held without application form and payment.

The fee will be \$180.00 for entire festival - either one day or both days.

IRISH FESTIVAL RULES

- *No vendors will be allowed to sell food or drinks.
- *No space will be assigned without receipt of application and payment.
- *Payment and application must be received by Friday, Feb. 23, 2018. There is an additional \$25 late charge for application received after Feb. 23, 2018. These funds must be verified.
- *The festival will take place rain or shine. No refunds will be made if vendor decides not to participate.
- *Vendors must comply with state tax laws. Cape Coral Irish American Club does not assume responsibility for tax payments.
- *You may not move from your assigned site.
- *Vendors are responsible for providing their own tent, table or shelving, and set-up for the sale or promotion of their items.
- *Vendors are not allowed to discharge any waste into the Park sewage system.
