



## **15th ANNUAL IRISH FESTIVAL MARCH 2<sup>nd</sup> & MARCH 3<sup>rd</sup>, 2019**

### **To Our Merchandise Vendors – Past and Future – Welcome!**

Please mark your calendars for the 15<sup>th</sup> Annual Cape Coral Irish Festival. The fest will take place on Saturday, March 2<sup>nd</sup> & Sunday, March 3<sup>rd</sup>, 2019. On Saturday the festival hours are 12 Noon to 8 PM. On Sunday, the festival starts at 12 Noon and continues until 8 PM. The venue for the festival will be at the German American Social Club (GASC) at 2101 SW Pine Island Road in Cape Coral, Florida 33991. Many vendors said they did well promoting or selling their product. We will be working diligently on placement of vendors to allow all vendors a good location on the grounds. The GASC is a great venue, where several festivals and public events are held every year. It's located on a main thoroughfare, visible to everyone passing by, with free parking and easy access to its huge parking areas. It is enclosed by permanent fencing and admission gates, and 24 hour security is provided. The park has electricity available for all vendors.

We ask that your booth space be eye-catching and if possible fit the theme of Irish culture. Vendors who are coming from a distance should make arrangements for overnight accommodations. No vendor will be allowed to stay overnight on festival grounds. The park will be locked at close of festival hours on Saturday evening. Vendors may set up after 12 PM on Friday, March 1st and after 8:30 AM on Saturday, March 2nd.

Each vendor will be given a site space and a number. Because we want to ensure that our vendors achieve maximum exposure for their wares, we will be limiting the number of vendor spaces available. Those vendors not accepted will have their money refunded. No site will be held without application form and payment.

The fee will be \$180.00 for the entire festival – either one day or both days.

### **IRISH FESTIVAL RULES**

- No vendors will be allowed to sell food or drinks.
- No space will be assigned without receipt of application and payment.
- Payment and application must be received by Friday, Feb. 22, 2019. There is an additional \$25 late charge for application received after Feb. 22, 2019. These funds must be verified.
- The festival will take place rain or shine. No refunds will be made if vendor decides not to participate.
- Vendors must comply with state tax laws. Cape Coral Irish American Club does not assume responsibility for tax payments.
- You may not move from your assigned site.
- Vendors are responsible for providing their own tent, table or shelving, and set-up.
- Vendors are not allowed to discharge any waste into the park sewage system.

- 'Numbered spaces measuring 10 feet by 10 feet will be assigned in advance

- 'All objects on display must be neatly arranged and prices clearly marked
- 'We will distribute vendor badges to be worn throughout the festival to help with security
- 'Security will be provided on Friday and Saturday nights
- 'Vendors are not allowed to discharge any waste into the park sewage system
- 'Vendors are not allowed to sell any food or drinks
