A fee of \$40 will be charged for any non-sufficient funds. Call 239-443-4457 with credit card payment information or fax forms to 239-558-8207 call this number first so it can be turned on.

Setup of all large items and all trailers must be completed the Friday before the event between noon and 6:00 PM, late setup will not be permitted and vendor fee will not be refunded.

Products can be setup the day of the event between 7 AM and 8:30 AM. No vehicles will be permitted in the event area after 8:30 AM.

When arriving to the site, unload all items on your site and REMOVE YOUR CARS, TURCKS, TRAILERS to the vendor parking area, do not setup your site until your vehicle has been moved to the vendor parking area. DO NOT SETUP ON ANY OTHER SPOT EXCEPT YOUR ASSIGNED SPOT, IT YOU DO YOU WILL HAVE TO MOVE.

The event does not permit exclusive vendor spots; our committee will do their best to not repeat too many of the exact kind of products. But keep in mind some vendors may be selling the same or like products as you.

Vendor placements are done in the order they are received with full payment and application. Placement will not happen until full payment is received. If you cancel you must give at least 4 week notice prior to the event date for any kind of refund.

NO TRASH, GARBAGE, ZIP TIES, CARBOARD OR SUPPLIES IS PERMITTED TO BE LEFT ON THE PROPERTY AT THE END OF THE EVENT. YOUR SPOT IS TO BE LEFT THE WAY YOU RECEIVED IT. ANY VENDOR NOT FOLLOWING THIS WILL BE CHARGE A \$100 CLEANING FEE THE FOLLOWING YEAR.

TWO LARGE EVENT DUMPSTERS ARE PROVIDED FOR YOUR USE ON THE VENDOR PARKING AREA. LOOK FOR OUR SIGNS ON THEM.
